Dear Mr. Williams,

My name is Adam Zarafshani. I used to be partners with Mr. White at 3443 Zen Gardens LLC. You may know it as Eightfold Development in Austin, Texas. Our partnership has been dissolved, and Zen Gardens is in Chapter 11 Bankruptcy. The asset has been sold to Romspen Mortgage in a credit bid. I have resigned from Mr. White's family trust in Canada, ECO Industria Park, and Absolute Waste Management. These documents are in Spanish, which I cannot read, but it appears that I have been listed as an officer of these companies. This was done without my knowledge or authorization. I understand that you represent Mr. White, and you are the attorney on record for these entities. Please be advised that I have nothing to do with Mr. White's organizations in South America and I do not want to be liable for any of his business activities.

I have been in litigation with Mr. White, his entities in Canada, and the United States for quite some time. He has alleged many things that are inaccurate, which is typical of his behavior. I never wanted to be involved in his activities in South America. I have always believed that Mr. White was involved in tax schemes and other illegal activities. This is an opinion in which I strongly believe. I am requesting you remove me from these documents effective immediately. If I am found liable for any activities these organizations have conducted, I will have no choice but to find you liable. This should have never been done without my consent. How is it possible that you have listed me as an officer or director without my consent or any communication with me?

I am copying this correspondence to my counsel, Daniel Stachnik, who will be making a formal request to have me removed immediately from Mr. White's counsel in Edmonton. I need verification that I have been removed. If I cannot receive proper documentation, I will have no choice but to refer this to the United States Federal Court, which is overseeing the bankruptcy case, and the court in Edmonton. I will follow up by contacting the FBI and the United States State Department.

I hope you do not take offense, but it was a big surprise to see these online. Considering Mr. White investigation by the Canadian Revenue Agency and the other legal matters that will be under investigation, I do not want to be involved in any of Mr. White's activities.
